TERMS OF REFERENCE (TOR)

1. SCOPE

1.1 Purpose

The purpose of this bid is to appoint a service provider for the determination of Residual Values and Remaining Useful Lives of Municipal Vehicles for GRAP measurement and disclosure in the Annual Financial Statements.

Vehicles owned by the municipality must be measured and recognised using the Cost –method of Depreciation where the depreciation of the vehicles are determined as the Cost – Residual Value = Depreciable Amount / Remaining Useful lives = Depreciation per annum. The Residual values and the remaining useful lives of vehicles need to be reviewed in order to calculate the correct book values of vehicles as at 30 June 2018.

The successful bidder will also be required to do a physical inspection of vehicles. The successful bidder must also provide the methodology used in determining the residual values and remaining useful lives.
