TERMS OF REFERENCE (TOR)

1. SCOPE

1.1. The purpose of the bid is to invite service providers for the **SUPPLY AND DELIVERY OF THREE PHASE PORTABLE ENERGY METERS CALIBRATION EQUIPMENT(RE-ADVERT)**. The equipment to be supplied is

- **THREE PHASE PORTABLE REFERENCE METER**
- **FLEXIBLE CURRENT CLAMPS**

On delivery of the equipment, the bidder shall provide an onsite training on how to operate all the above equipment to a minimum of six (6) municipal employees. It should also be noted that this will be a once-off purchase and it includes supply, delivery and off-loading of equipment at the municipal offices in Ceres, Western Cape

1.2. Background and description of the project

Witzenberg Municipality is a local authority situated within the Cape Winelands District Municipality. The municipality holds a NERSA-issued electricity distribution licence and is responsible for supplying electricity to the towns of Ceres, Tulbagh, and Wolseley. A combination of STS-compliant prepaid and postpaid meters, electromechanical meters, and electronic energy demand meters are currently in use across the network.

Electricity meters are critical to the municipality's revenue collection processes. It is therefore essential that these meters provide accurate measurements of each customer's energy consumption.

The procurement of portable three-phase energy meter calibration equipment will enable the Electro-technical Services technicians to perform on-site accuracy testing of electricity meters and to verify installation correctness.

1.3. Pre-Qualification Criteria

- 1.3.1. The bidder must have successfully supplied at least 2 customers with similar equipment (three-phase portable energy meters calibration equipment) within the borders of South Africa. Bidders are required to complete the schedule on page 5 of the bid document to prove their previous experience.
- 1.3.2. Bidders must demonstrate the ability to offer technical support for the equipment supplied, within the borders of South Africa. Proof of a registered service center or office located within South Africa, where technical queries can be forwarded to. A letter on official company letterhead confirming the physical location and operational status of the service centre/office, to be submitted.

1.4. Special Conditions of Contract

- 1.4.1 Tenderers to clearly indicate the delivery period in weeks. Tenderers who do not indicate the delivery period may not be considered for further evaluation.
- 1.4.2 Calibration certificate must be supplied upon delivery of the equipment. Calibration certificates must be traceable to a SANAS-accredited or IEC 17025 laboratory.
- 1.4.3 Witzenberg Municipality reserves the right to procure items through other means should the successful bidder be unable to deliver.
- 1.4.4 The pricing shall be firm for the duration of the bid; no escalation or increases will be allowed.
- 1.4.5 Manufacturer Authorisation Proof of dealership or official authorisation from original equipment manufacturer (OEM), proof to be submitted upon delivery of the equipment.
