TERMS OF REFERENCE (TOR)

1. SCOPE

1.1 Purpose

1.1.1. The purpose of this bid is to invite qualified and experienced service providers to submit a bid for **GEOTECHNICAL SERVICE PROVIDER (GSP) FOR GEOTECHNICAL INVESTIGATION OF CILLIER STREET, CERES .**

1.2 Witzenberg Municipality includes the following towns and rural areas

- Ceres;
- Prince Alfred's Hamlet;
- Op-die-berg;
- Tulbagh; and
- Wolseley

Witzenberg Municipality is required to deliver services to the abovementioned areas.

A. THE GEOTECHNICAL SERVICE PROVIDER (GSP) SHALL UNDERTAKE ALL WORK NECESSARY TO:

1. **Collect existing information** and establish expected ground conditions.
2. **Assess current pavement condition** and causes of distress (rutting, cracking, pumping, settlement, edge failure, etc.).
3. **Determine pavement layer thicknesses**, material types, moisture condition, density/compaction state, and variability.
4. **Characterise the subgrade** and near-surface geology for bearing capacity, compressibility, expansiveness/collapsibility, erodibility, and moisture sensitivity.
5. **Evaluate groundwater and drainage** conditions affecting pavement performance.
6. Provide **geotechnical parameters** and **pavement design inputs** (e.g., CBR, stiffness indicators, material classifications) and recommendations for:
 - reworking/undercutting,
 - stabilisation,
 - improved drainage,
 - geosynthetics (where appropriate),
 - construction platform requirements,
 - compaction and moisture controls.
7. Provide **construction recommendations and risk notes** suitable for inclusion in contract documentation.
8. **Classification: Soil:**
 - Grading properties (75mm to 2µm)
 - Atterberg limits
 - Maximum compacted density and optimum moisture content
 - California bearing ratio
 - Corrosivity
 - Erodibility

B. OBJECTIVES

Objective of the preliminary Geotechnical Site Investigation

The primary objective is to **determine the physical, mechanical, and chemical properties of the soil and rock along the proposed road alignment** in order to:

1. **Assess Ground Conditions**
 - Identify soil and rock types, stratification, groundwater levels, and geological features.
2. **Evaluate Suitability for Road Foundations**
 - Determine whether the in-situ materials are suitable for subgrade, fill, or embankment construction.
3. **Identify Potential Geotechnical Hazards**
 - Detect risks such as collapsible soils, expansive clays, soft ground, slope instability, sinkholes, or high water tables.
4. **Provide Parameters for Design**
 - Obtain geotechnical design parameters (bearing capacity, shear strength, compaction characteristics, CBR values, settlement potential).
5. **Optimize Road Alignment and Construction Methods**
 - Inform decisions on alignment, cut-and-fill requirements, drainage design, pavement layers, and construction techniques.
6. **Ensure Safety and Long-Term Performance**
 - Prevent premature pavement failures, uneven settlements, embankment failures, or slope instability.
7. **Support Cost-Effective Planning**
 - Reduce costly redesigns, delays, and maintenance by accurately understanding ground conditions early in the project.
