The purpose of the bid is to invite service providers for the **SUPPLY AND DELIVERY OF STEEL CONTAINERS** to Witzenberg Municipality.

1.1. Background and description of the project

Witzenberg Municipality includes the towns and rural areas of:

1.3. Pre-Qualification Criteria

- 1.3.1. Bidder must have successfully completed at least one similar project in the supply and delivery of steel containers(s)(shipping containers) over the past 5 years. NB: Witzenberg Municipality may verify any information submitted in terms of this document and any information that is incorrect may result in the bid being automatically disqualified and not considered further.
